3. Please submit **\$395.00** to enroll in both portions at the same time.
4. A license or learner's permit is required to actually drive. The Pennsylvania Drivers Licensing Exam is given to full time students who have completed the classroom and behind-the-wheel, and have not graduated from high school.
5. Any class absence must be made up in the next session.

DRIVER EDUCATION TRAINING **CLASSROOM/BEHIND-THE-WHEEL/DRIVERS LICENSING EXAM**

North Montco Technical Career Center provides a **Pennsylvania Department of Education (PDE) approved Classroom and Behind-The-Wheel Drivers Training Program** for all interested students. This program meets Pennsylvania Department of Education regulations and insurance industry requirements.

The **Classroom instruction** consists of 30 hours of instruction provided by certified teachers at the Technical Career Center. Classes are scheduled after school, evening and summer hours for students who are 16 or turn 16 by the end of summer. Students who are 18 or over and are full time students are required to have a permit. Program registration can be accomplished by completing the Classroom registration form and sending it to North Montco Technical Career Center with payment enclosed. **Payment can be made by personal check, VISA or MASTERCARD.** Students will be scheduled by North Montco based upon their session selection.

For registration confirmation—enclose a self-addressed stamped envelope with registration

North Montco also provides **Behind-the-Wheel** training consisting of 6 hours of actual driving with instruction in dual-controlled cars provided by North Montco, and **Drivers Licensing Exam** given during the 6th hour. Instruction is scheduled on an individual basis. **All instructors are part time PA certified and driving is according to their schedule.** Eligible students must be 16 years or older, have obtained their learner's permit or license, and successfully completed the 30 hours of classroom instruction at North Montco TCC or any other PDE approved location. **Proof of PDE approved 30 hour classroom training required if student did not attend classroom instruction at North Montco TCC.** A registration form must be submitted with payment enclosed in order to schedule Behind-the-Wheel instruction. **The school must be notified 24 hour prior to the cancellation, or students will be charged for the time scheduled and will need to schedule additional hours above the original 6 hours at a \$45.00 per hour fee.**

Students who successfully complete the 30 hours Classroom instruction and the 6 hours Behind-The-Wheel will receive certificates. Both certificates are required by most insurance companies for a reduction in insurance premiums. **The Pennsylvania Drivers Licensing Exam is given to full time students who have completed the classroom and behind-the-wheel, and have not graduated from high school.**

Behind-The-Wheel Enrollees

The names of the Behind-the Wheel enrollees who have their learner's permit, will be kept on file until you notify us, and give the permission to begin the Behind-The-Wheel training. On the reverse side is the registration form necessary for enrollment and a schedule of classroom sessions.
